**State Scholarships**

**1. E-grantz Scholarship (for SC/ST/OEC)**

- The applicant should be a domicile of Kerala state.
- The applicants should not have an attendance of less than 75% at the end of each month.
- The candidate should have taken admission under the merit and reservation quota.
- Students belonging to SC/ ST/ Other Eligible community [OEC] are eligible to apply.

**2 .E-grantz Scholarship (for OBC/General merit students)**

- The applicant should be a domicile of Kerala state.
- The applicants should not have an attendance of less than 75% at the end of each month.
- The candidate should have taken admission under the merit and reservation quota.
- Students belonging to OBC/FC are eligible to apply.
- The annual family income of the students should not exceed INR 1,00,000

**3 E-grantz Scholarship (FISHERIES) (For children of registered fishermen)**

- Fisheries Grant – Educational concession to the children of registered fishermen from Fisheries Development Department.
- Application forms are available only from Fisheries office. Applicants should submit their hard copy of application along with the supporting certificates, within 30 days of admission. (No income limit.)

**4 Vidya Sammunnathi Scholarship**  
(For non-reservation forward community)

- The applicant should be a domicile of Kerala state
- Should be from the non-reservation forward community
- Scholarship will be awarded to the students who have secured not less than 70% marks or equivalent grade in the previous final examination
- Annual income from all sources does not exceed Rs.4.00 lakh

**5 C. H. Mohammed Koya Scholarship (CHMS) for Girls**

- Should belong to Muslim, Latin, Converted Christian community (Girls only) and should be a native of Kerala
- Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination
- Annual income from all sources does not exceed Rs.8.00 lakh

**6 KSSM Snehapoorvam Scholarship**  
(For the students of Kerala whose father or mother or both have passed away)

- Those who belonging to APL category, annual income is below than Rs.20, 000 in rural areas and Rs. 22,375 in urban areas (Corporation / Municipality) can grab this opportunity.
- Students who are belongs to BPL category

**Central Scholarships**

**1 Merit Cum Means Scholarship for Professional and Technical Courses CS**  
For Minorities: Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians  
(Parsis)

- Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination
- Annual income from all sources does not exceed Rs.2.50 lakh

**2 Central Sector Scheme of Scholarship for College and University Students**

- Scholarship will be awarded to the students who have secured not less than 80% marks or equivalent grade in the previous final examination
- Annual income from all sources does not exceed Rs.6.00 lakh

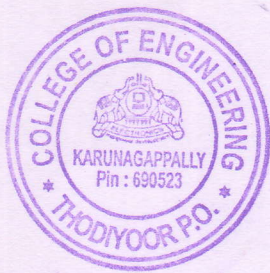
**3 Post Matric Scholarships Scheme for Minorities**

For Minorities: Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis)

- Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination
- Annual income from all sources does not exceed Rs.2.00 lakh

**4 PRAGATI Scholarship Scheme for Girls Students (AICTE)**

- The girl candidate should be admitted to First year of Degree level course  
OR
- Second year of Degree level course through lateral entry in any of the AICTE approved Institution of respective year
- Annual income from all sources does not exceed Rs.8.00 lakh
