the submission of quotations.


The acceptance of the quotation rests with the officer inviting quotations who does not (3)

undertake to accept the lowest or any particular quotation.

The successful bidder within seven days of receipt of the selection notice shall deposit an (4) amount equal to 5 % of contract amount which shall be treated as Security Deposit for the proper fulfillment of the work and he shall also execute an agreement for the work in the standard format.

Security deposit will be released to the contractor only after the expiry of defects liability (5) period. Defects liability period is 6 months from the date of completion of work

- The quantities shown in the schedule are only approximate and are subject to variation (6)and if found necessary the contractor is bound to do additional quantities up to 25% above estimate quantities of each item of work at his quoted rate. If any extra items of work not included in the schedule are executed, its rate will be arrived at on the basis of rules followed in Kerala PWD.
- Time is the essence of the contract. The work shall be completed within ......15 days (7) from the date of receipt of written order to commence the work. If the work is not completed by the agreed date liquidated damages will be recovered from the contractor for the delay, in accordance with the prevailing rules in Kerala PWD
- Contractor shall appoint qualified engineering representative at site to supervise the work. (8)
